INTRODUCTION

Football Queensland has created this Guide to provide clubs and local councils with filming platform standards for football facilities.

All clubs involved in Premier competitions (National Premier Leagues Queensland and Football Queensland Premier League 1 & 2 competitions) must have a permitted filming structure prior to the start of the 2023 competition.

Community clubs are encouraged to use this Guide to ensure all existing permanently fixed filming structures meet the requirements, and that the requirements are met when installing a filming platform prior to the club's promotion to Premier competitions.

All clubs must obtain landowner's consent for new and existing filming structures.

REQUIREMENTS

There are two types of filming structures – permanent and temporary.

A temporary structure is not permanently fixed and is temporarily constructed or erected for the purpose of a viewing platform or filming of football.

A permanent structure is fixed at all times.

Filming platforms that are permanently fixed and meet the criteria in this Guide are permitted for use and covered by insurance with Football Queensland.

For the 2023 year, insurance coverage in relation to your Public and Products Liability Policy, for the purposes of viewing and filming football, will only be in place for temporary structures if either of the below two conditions is met:

1. The below three conditions are met in relation to the temporary structure:
 - The temporary structure is provided by a third party; and
 - The temporary structure is installed by a third party; and
 - The Club obtains and provides to FQ a copy of the Certificate of Currency from the provider/installer of the temporary structure. We recommend that this Certificate of Currency provides a minimum of \$20m of Public and Products Liability coverage.
2. The temporary structure is converted into a fixed structure.
 - Temporary structure – means any constructed or erected structure for the purpose of a viewing platform or filming football. Temporary structures do not include fixed structures.
 - Fixed structure – a structure is deemed to be fixed when the structured is fixed in place by bolts, concrete, or another fixed method and remains in place.

Premier Clubs

Specific structural requirements of permitted permanent and temporary filming structures:

- Must be easily accessible.
- Access to the platform must accommodate one person with necessary gear to navigate through safely, while the platform itself should accommodate two people and the necessary camera and live streaming equipment.
- Minimum height of 1.5m (recommended height is 4.3m or 2 storeys).
- Minimum distance from the sideline and any other object is 3m.
- Minimum standard dimensions of a platform are 2400mm x 1200mm.
- Shelter (and all structural poles) must not obstruct the view of the entire field (including near-side corners).
- Filming platform must have adequate shelter to keep filming equipment and personnel protected from weather.
- Be located within 50m of the main power sources in a safe location. Power must meet AS/NZS 3112 standard. Fixed power sources within the filming platform are preferred.

Community Clubs

Clubs that do not participate in Premier Competitions are not required to have a filming platform.

Filming platforms that meet the requirements in this Guide and are fully certified, compliant, and covered by insurance are permitted for use.

FQ encourages aspirational clubs to explore funding opportunities to invest in a filming structure to meet the requirements for Premier competitions.

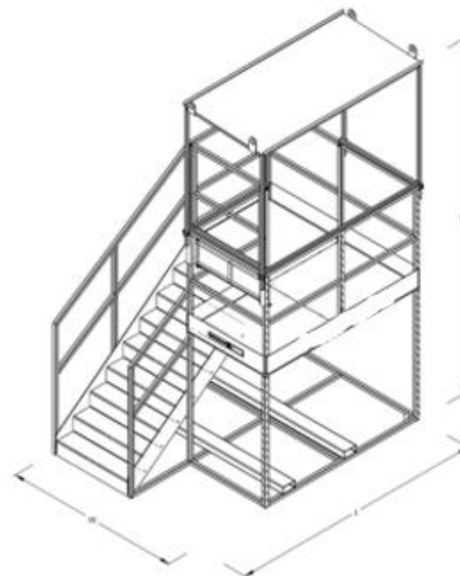
