

## MATCH REVIEW PANEL

---

### THURSDAY 21 MARCH 2024

On Thursday 21 March 2024, the Football Queensland Match Review Panel (MRP) convened to consider several incidents arising from Round 4 of the NPL Queensland Men & FQPLI Men competitions.

#### **Gold Coast Knights vs Rochedale Rovers – Aidan Collins (Rochedale Rovers)**

The MRP considered an incident involving Aidan Collins of Rochedale Rovers on or around the 92<sup>nd</sup> minute of Rochedale Rovers' NPL QLD Men match against Gold Coast Knights on Friday 15 March 2024.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Collins was issued with a direct Red Card by the Referee.

The MRP determined that Collins committed the offence of "R-TO3 03-01 Use offensive, insulting or abusive language and/or gestures" from Table C of the Regulations Table of Offences. The minimum sanction for the offence is two (2) matches, being the Mandatory Match Suspension plus one (1) additional fixture.

The MRP confirmed that Collins will serve a suspension of two (2) matches, being the minimum sanction for the offence.

#### **Capalaba FC vs Moreton City Excelsior – Jack Shaw (Capalaba FC)**

The MRP considered an incident involving Jack Shaw of Capalaba FC on or around the 96<sup>th</sup> minute of Capalaba FC's FQPLI Men match against Moreton City Excelsior on Saturday 16 March 2024.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Shaw was issued with a direct Red Card by the Referee.

The MRP determined that Shaw committed the offences of "R1 03-01 Conduct that endangers the safety of an opponent in a contest for the ball or has the potential to cause injury" & "R8 02-01 Disputing a decision of a Match Official or dissent". The minimum sanction for the two offences is five (5) matches, being the Mandatory Match Suspension plus four (4) additional fixtures.

The MRP confirmed that Shaw will serve a suspension of five (5) matches, being the minimum sanction for the offences. The MRP notes that contact with a referee by players will not be tolerated at any time.

### **Capalaba FC vs Moreton City Excelsior – Mikhail Hastings (Capalaba FC)**

The MRP considered an incident involving Mikhail Hastings of Capalaba FC on or around the 65<sup>th</sup> minute of Capalaba FC's FQPLI Men match against Moreton City Excelsior on Saturday 16 March 2024.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Hastings was issued with a direct Red Card by the Referee.

The MRP determined that Hastings committed the offence of "R1 01-01 Serious foul play tackle". The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Hastings will serve a suspension of one (1) match, being the minimum sanction for the offence.

### **Caboolture FC vs Broadbeach United – Lachlan Kelly (Caboolture FC)**

The MRP considered an incident involving Lachlan Kelly of Caboolture FC on or around the 67<sup>th</sup> minute of Caboolture FC's FQPLI Men match against Broadbeach United on Sunday 17 March 2024.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Kelly was issued with a direct Red Card by the Referee.

The MRP determined that Kelly committed the offence of "R1 01-01 Serious foul play tackle". The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Kelly will serve a suspension of one (1) match, being the minimum sanction for the offence.

### **Logan Lightning vs St George Willawong – Sean Sacco (Logan Lightning)**

The MRP considered an incident involving Sean Sacco of Logan Lightning on or around the 56<sup>th</sup> minute of Logan Lightning's FQPLI Men match against St George Willawong on Saturday 16 March 2024.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Sacco was issued with a direct Red Card by the Referee.

The MRP determined that Sacco committed the offence of "R1 03-01 Conduct that endangers the safety of an opponent in a contest for the ball or has the potential to cause injury". The minimum sanction for the offence is four (4) matches, being the Mandatory Match Suspension plus three (3) additional fixtures.

The MRP confirmed that Sacco will serve a suspension of four (4) matches, being the minimum sanction for the offence.

### **Ipswich FC vs Eastern Suburbs – Luke Murphy (Eastern Suburbs)**

The MRP considered an incident involving Luke Murphy on or around the 88<sup>th</sup> minute of Eastern Suburbs' FQPL1 Men match against Ipswich FC on Saturday 16 March 2024.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Murphy was issued with a direct Red Card by the Referee.

The MRP determined that Murphy committed the offence of "R6 02-01 Using language and/or gestures directed at another person". The minimum sanction for the offence is two (2) matches, being the Mandatory Match Suspension plus one (1) additional fixture.

The MRP confirmed that Murphy will serve a suspension of two (2) matches, being the minimum sanction for the offence.

### **SWQ Thunder vs Mitchelton FC – Wilfred Phillip (SWQ Thunder)**

The MRP considered an incident involving Wilfred Phillip on or around the 87<sup>th</sup> minute of SWQ Thunder's FQPL1 Men match against Mitchelton FC on Saturday 16 March 2024.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Phillip was issued with a direct Red Card by the Referee.

The MRP determined that Phillip committed the offence of "R2 01-01 Excessive conduct when the ball is not in play or playing distance". The minimum sanction for the offence is two (2) matches, being the Mandatory Match Suspension plus one (1) additional fixture.

The MRP confirmed that Phillip will serve a suspension of two (2) matches, being the minimum sanction for the offence.
