

## MATCH REVIEW PANEL

---

### THURSDAY 19 JUNE 2025

On Thursday 19 June 2025, the Football Queensland Match Review Panel (MRP) convened to consider three incidents arising from Round 14 of the NPL Men competition.

#### **NPL Men: Gold Coast United vs Brisbane City – Fraser Hills (Gold Coast United)**

The MRP considered an incident involving Fraser Hills on or around the 93<sup>rd</sup> minute of Gold Coast United's NPL Men fixture against Brisbane City on Saturday 14 June 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Hills was issued with a direct Red Card by the referee.

The MRP determined that Hills committed the offence of '*R2 01-01 Excessive conduct when the ball is not in play or playing distance*'. The minimum sanction for the offence is two (2) matches, being the Mandatory Match Suspension plus one (1) additional fixture.

The MRP confirmed that Hills will serve a suspension of two (2) matches, being the minimum sanction available for the offence.

#### **NPL Men: Gold Coast United vs Brisbane City – Corey Brown (Brisbane City)**

The MRP considered an incident involving Corey Brown on or around the 35<sup>th</sup> minute of Brisbane City's NPL Men fixture against Gold Coast United on Saturday 14 June 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Brown was issued with a direct Red Card by the referee.

The MRP determined that Brown committed the offence of '*R1 01-01 Serious foul play tackle*'. The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Brown will serve a suspension of one (1) match, being the minimum sanction available for the offence.

#### **NPL Men: St George Willawong vs Gold Coast Knights – Scott McDonald (Gold Coast Knights)**

The MRP considered an incident involving Scott McDonald after full time of Gold Coast Knights' NPL Men fixture against St George Willawong on Saturday 14 June 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as McDonald was issued with a direct Red Card by the referee.

The MRP determined that McDonald committed the offence of *'R8 02-02 Disputing a decision of a Match Official or dissent'*.

The MRP noted that the incident constitutes McDonald's second R8 offence in a two year period, which in accordance with Section 9.13 of the Regulations requires McDonald to be levelled with a 'Second and subsequent' level sanction.

The minimum sanction for this 'Second and subsequent' offence is three (3) matches, being the Mandatory Match Suspension plus two (2) additional fixtures.

The MRP confirmed that McDonald will serve a suspension of three (3) matches, being the minimum sanction available for the offence.
