

MATCH REVIEW PANEL

THURSDAY 26 JUNE 2025

On Thursday 26 June 2025, the Football Queensland Match Review Panel (MRP) convened to consider four incidents arising from the NPL and FQPL 1 Men competitions.

FQPL 1 Men: Capalaba FC vs Ipswich FC: Luca Damianakis (Ipswich FC)

The MRP considered an incident involving Luca Damianakis on or around the 80th minute of Ipswich FC's FQPL 1 Men fixture against Capalaba FC on Saturday 21 June 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Damianakis was issued with a direct Red Card by the referee.

The MRP determined that Damianakis committed the offence of 'R6 02-01 Using language and/or gestures directed at another person'. The minimum sanction for the offence is two (2) matches, being the Mandatory Match Suspension plus one (1) additional fixture.

The MRP confirmed that Damianakis will serve a suspension of two (2) matches, being the minimum sanction available for the offence.

FQPL 1 Men: Caboolture Sports FC vs Broadbeach United – Liam Goulding (Broadbeach United)

The MRP considered an incident involving Liam Goulding on or around the 4th minute of Broadbeach United's FQPL 1 Men fixture against Caboolture Sports FC on Saturday 21 June 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Goulding was issued with a direct Red Card by the referee.

The MRP determined that Goulding committed the offence of 'R5 Denying an obvious goal scoring opportunity to an opponent moving towards the opponent's goal by an offence punishable by a free kick'. The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Goulding will serve a suspension of one (1) match, being the minimum sanction available for the offence.

NPL Men: Peninsula Power vs Wynnum Wolves – Josh Woolley (Peninsula Power)

The MRP considered an incident involving Josh Woolley on or around the 45th minute of Peninsula Power's NPL Men fixture against Wynnum Wolves on Wednesday 25 lune 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Woolley was issued with a direct Red Card by the referee.

The MRP determined that Woolley committed the offence of 'R1 01-01 Serious foul play tackle'. The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Woolley will serve a suspension of one (1) match, being the minimum sanction available for the offence.

NPL Men: St George Willawong vs Gold Coast Knights

The MRP considered multiple incidents involving spectators during the St George Willawong vs Gold Coast Knights NPL Men fixture on Saturday 14 June 2025.

St George Willawong were issued with a Show Cause Notice (the **Notice**) pertaining to these incidents on Tuesday 17 June 2025. The club subsequently provided a response to the **Notice** on Friday 20 June 2025.

The MRP considered St George Willawong's response to the Notice, alongside available broadcast footage of the incidents and additional reporting supplied.

The MRP has determined that St George Willawong be charged under offence code '25-01 Letting off incendiary device(s) or fire(s)' from Table E of the **Regulations.**

The MRP confirmed that under this charge St George Willawong will be fined \$1500 and issued with a three (3) point deduction for their NPL Men team. The **three (3) point deduction is fully suspended for a period of six (6) months**, triggered by any further instances of the same offence/charge by St George Willawong spectators at NPL Men matches.

The MRP would like to thank St George Willawong for their cooperation, and remind all participants that Football Queensland has a zero tolerance policy regarding flares, fireworks and other incendiary devices or fires at matches.
