

MATCH REVIEW PANEL

THURSDAY 10 JULY 2025

On Thursday 10 July 2025, the Football Queensland Match Review Panel (MRP) convened to consider four incidents arising from the NPL & FQPL 1 Men competitions.

NPL Men: Sunshine Coast Wanderers vs Moreton City Excelsior – Stefan Cordwell (Sunshine Coast Wanderers)

The MRP considered an incident involving Stefan Cordwell on or around the 29thminute of Sunshine Coast Wanderers' NPL Men fixture against Moreton City Excelsior on Friday 4 July 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Cordwell was issued with a direct Red Card by the referee.

The MRP determined that Cordwell committed the offence of 'R6 02-01 Using language and/or gestures directed at another person'. The minimum sanction for the offence is two (2) matches, being the Mandatory Match Suspension plus one (1) additional fixture.

The MRP confirmed that Cordwell will serve a suspension of two (2) matches, being the minimum sanction available for the offence.

NPL Men: Sunshine Coast Wanderers vs Moreton City Excelsior – Liam Fitzsimmons (Sunshine Coast Wanderers)

The MRP considered an incident involving Liam Fitzsimmons on or around the 35th minute of Sunshine Coast Wanderers' NPL Men fixture against Moreton City Excelsior on Friday 4 July 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Fitzsimmons was issued with a direct Red Card by the referee.

The MRP determined that Fitzsimmons committed the offence of 'R2 01-01 Excessive conduct when the ball is not in play or playing distance'. The minimum sanction for the offence is two (2) matches, being the Mandatory Match Suspension plus one (1) additional fixture.

The MRP confirmed that Fitzsimmons will serve a suspension of two (2) matches, being the minimum sanction available for the offence.

FQPL 1 Men: Brisbane Strikers vs Redlands United – Isaac Garcia (Redlands United)

The MRP considered an incident involving Isaac Garcia on or around the 14th minute of Redlands United's FQPL1 Men fixture against Brisbane Strikers on Sunday 6 July 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Garcia was issued with a direct Red Card by the referee.

The MRP determined that Garcia committed the offence of 'R1 03-01 Conduct that endangers the safety of an opponent in a contest for the ball or has the potential to cause injury'. The minimum sanction for the offence is three (3) matches, being the Mandatory Match Suspension plus two (2) additional fixtures.

The MRP confirmed that Garcia will serve a suspension of three (3) matches, being the minimum sanction available for the offence.

FQPL 1 Men: Magic United vs Broadbeach United - Luke Kunde (Broadbeach United)

The MRP considered an incident involving Luke Kunde after full time of Broadbeach United's FQPL1 Men fixture against Magic United on Sunday 6 July 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Kunde was issued with a direct Red Card by the referee.

The MRP determined that Kunde committed the offence of 'R8 02-01 Disputing a decision of a Match Official or dissent'. The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Kunde will serve a suspension of one (1) match, being the minimum sanction available for the offence.

The MRP would like to remind all participants that Football Queensland has a zero tolerance policy regarding inappropriate interactions between Coaches and Match Officials before, during or after matches.
