

MATCH REVIEW PANEL

THURSDAY 14 AUGUST 2025

On Thursday 14 August 2025, the Football Queensland Match Review Panel (MRP) convened to consider four incidents arising from the FQPL 1 Men competition.

FQPL 1 Men: Southside Eagles vs Holland Park Hawks – Hunter Rutty (Holland Park Hawks)

The MRP considered an incident involving Hunter Rutty of Holland Park Hawks on or around the 65th minute of Holland Park Hawks' FQPL 1 Men fixture against Southside Eagles on Saturday 9 August 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Rutty was issued with a direct Red Card by the referee.

The MRP determined that Rutty committed the offence of '*R1 02-01 Attempting to gain possession of the ball using excessive force.*' The minimum sanction for the offence is two (2) matches, being the Mandatory Match Suspension plus one (1) additional fixture.

The MRP confirmed that Rutty will serve a suspension of two (2) matches, being the minimum sanction available for the offence.

FQPL 1 Men: Southside Eagles vs Holland Park Hawks – Van Francis (Southside Eagles)

The MRP considered an incident involving Van Francis of Southside Eagles on or around the 5th minute of Southside Eagles' FQPL 1 Men fixture against Holland Park Hawks on Saturday 9 August 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Francis was issued with a direct Red Card by the referee.

The MRP determined that Francis committed the offence of '*R5 Denying an obvious goal-scoring opportunity to an opponent moving towards the opponent's goal by an offence punishable by a free kick.*' The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Francis will serve a suspension of one (1) match, being the minimum sanction available for the offence.

FQPL 1 Men: Southside Eagles vs Holland Park Hawks – Sam Gahan (Southside Eagles)

The MRP considered an incident involving Sam Gahan of Southside Eagles at full time of Southside Eagles' FQPL 1 Men fixture against Holland Park Hawks on Saturday 9 August 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Gahan was issued with a direct Red Card by the referee.

The MRP determined that Gahan committed the offence of '*R8 04-01 Use offensive, insulting or abusive language and/or gestures towards a Match Official.*' The minimum sanction for the offence is four (4) matches, being the Mandatory Match Suspension plus three (3) additional fixtures.

The MRP confirmed that Gahan will serve a suspension of four (4) matches, being the minimum sanction available for the offence.

FQPL 1 Men: Caboolture Sports FC vs Redlands United – Lachlan Hunter (Caboolture Sports FC)

The MRP considered an incident involving Lachlan Hunter of Caboolture Sports FC on or around the 28th minute of Caboolture Sports FC's FQPL 1 Men fixture against Redlands United on Saturday 9 August 2025.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Hunter was issued with a direct Red Card by the referee.

The MRP determined that Hunter committed the offence of '*R1 03-01 Conduct that endangers the safety of an opponent in a contest for the ball or has the potential to cause injury.*' The minimum sanction for the offence is three (3) matches, being the Mandatory Match Suspension plus two (2) additional fixtures.

The MRP confirmed that Hunter will serve a suspension of five (5) matches, being two (2) matches above the minimum sanction which reflects the severity of the incident in question.
