

MATCH REVIEW PANEL

THURSDAY 23 APRIL 2026

On Thursday 23 April 2026, the Football Queensland Match Review Panel (MRP) convened to consider three incidents arising from the NPL Men & FQPL 1 Men competitions.

NPL Men: Wynnum Wolves vs Gold Coast Knights – Kai Partridge (Wynnum Wolves)

The MRP considered an incident involving Kai Partridge of Wynnum Wolves on or around the 58th minute of Wynnum Wolves' NPL Men fixture against Gold Coast Knights on Friday 17 April 2026.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Partridge was issued with a direct Red Card by the referee.

The MRP determined that Partridge committed the offence of '*R5 Denying an obvious goal-scoring opportunity to an opponent moving towards the opponent's goal by an offence punishable by a free kick*'. The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Partridge will serve a suspension of one (1) match, being the minimum sanction available for the offence.

NPL Men: Brisbane Roar B vs Olympic FC – George Plusnin (Brisbane Roar B)

The MRP considered an incident involving George Plusnin of Brisbane Roar B on or around the 13th minute of Brisbane Roar B's NPL Men fixture against Olympic FC on Sunday 19 April 2026.

In accordance with the Football Queensland Disciplinary Regulations (the **Regulations**), the MRP has the authority to consider the incident as Plusnin was issued with a direct Red Card by the referee.

The MRP determined that Plusnin committed the offence of '*R5 Denying an obvious goal-scoring opportunity to an opponent moving towards the opponent's goal by an offence punishable by a free kick*'. The minimum sanction for the offence is one (1) match, being the Mandatory Match Suspension.

The MRP confirmed that Plusnin will serve a suspension of one (1) match, being the minimum sanction available for the offence.

FQPL 1 Men: Holland Park Hawks vs Capalaba FC – Hayden Whyte (Capalaba FC)

The MRP considered an incident involving Hayden Whyte of Capalaba FC on or around the 1st minute of second half stoppage time in Capalaba FC's FQPL 1 Men fixture against Holland Park Hawks on Friday 17 April 2026.
